- B. East Coast Erosion Blankets, LLC is not liable or responsible for any loss or damage resulting from or occurring by reason of unavailability of product.
- C. East Coast Erosion Blankets, LLC is not liable or responsible for any loss or damage resulting from delay in shipment or receipt of order for reasons including, but not limited to, temporary product or raw material shortages, order backlogs, equipment failure, unavailability of freight or transportation, natural disasters, embargoes, or any other cause outside of the reasonable control of East Coast Erosion Blankets, LLC.
- D. In the event that any raw material specified for a requested product included in the quotation shall become unavailable, East Coast Erosion Blankets, LLC shall notify the Customer. East Coast Erosion Blankets, LLC may at its sole discretion recommend a comparable product. East Coast Erosion Blankets, LLC is not liable or responsible for loss or damages for the use of this tool. - B. All products manufactured by East Coast Erosion Blankets, LLC remain the intellectual property of East Coast Erosion Blankets, LLC, inclusive of custom orders, unless design is previously protected under alternate patent protections and being manufactured with express written consent, or otherwise agreed upon by East Coast Erosion Blankets, LLC. PRICES

- A. These Terms of Sale together with the Customer credit terms and conditions, if applicable, and the quote constitute the entire agreement between East Coast Erosion Blankets, LLC and Customer regarding the subject matter hereof and supersedes and replaces all prior and collateral representations, promises, and conditions in connection with such subject matter. i) Except in the event that East Coast Erosion Blankets, LLC has expressly entered an additional terms and conditions agreement with an individual Customer, independent of agreements with Customers on the whole.
- B. All purchase orders submitted shall be subject solely to these Terms of Sale, and any additional terms contained in quotation; any preprinted or linked terms on a Customer purchase order form or similar form are objected to and shall not alter or amend the terms of these Terms of Sale.
 - No individual or company may purchase goods on credit without prior approval of East Coast Erosion Blankets, LLC and all such purchases shall be subject to compliance with the determined terms of credit. In the absence of East Coast Erosion Blankets, LLC credit approval, all orders will be remitted upon receipt of payment.
- C. East Coast Erosion Blankets, LLC reserves the right, at its sole discretion, to require a personal guaranty before approving any credit arrangement.
- D. Purchaser is responsible for all applicable taxes. This includes all federal, state, municipal or other governmental authority taxes with respect to the sale or shipment of goods. - G. Special order materials and/or custom products requested by Customer cannot be returned to East Coast Erosion Blankets, LLC except in cases of manufacturer defect or with prior approval by East Coast Erosion Blankets, LLC. Customer must accept delivery and remit payment within established terms, in absence of manufacturing defect or other error within the control of East Coast Erosion Blankets, LLC.
- H. Special order materials and non-stock items which are required to fulfill a Customer order become the responsibility of the Customer.
- I. Any representation, promise, or condition not incorporated herein shall not be binding to East Coast Erosion Blankets, LLC, except where amended under the conditions of section 3.a.i. In any successful action by a party hereto, the prevailing party shall be entitled to recover reasonable attorneys' fees and costs of court incurred in such action.
- J. East Coast Erosion Blankets, LLC certifies that these goods were produced in compliance with all applicable requirements of Sections 6, 7 and 12 of the Fair Labor Standards Act, as amended and of regulations and orders of the United States Department of Labor issued under Section 14 thereof.
- K. East Coast Erosion Blankets, LLC reserves the right to modify or change the Terms of Sale contained herein without notice. SHIPMENT, TITLE, RISK OF LOSS, WAIVER OF CLAIMS

- A. The provided freight quotes are merely an estimate of freight charges and may necessarily fluctuate based on multiple variables. The actual charges will be based on the shipment's requested transit time and additional services performed including, but not limited to, making a delivery appointment phone call, having to re-deliver, delivering to a residential location, delivering to a remote site, needing special equipment to offload the product, having the driver assist in unloading the product, excessive unloading wait times, etc. Estimated figures are subject to alteration without pre-advice. Estimated transit time may vary at the discretion of the carrier. Additional fees may be charged for Guaranteed Deliveries.
- B. All prices and shipments are Free on Board (FOB) point of shipment. Title and all risk transfers to the Customer upon presentation of the goods to the carrier.
- C. If, upon Customer request, East Coast Erosion Blankets, LLC quotes a Common Carrier freight rate for a "Pre-Pay and Add" shipment, all costs are the sole responsibility of the Customer. East Coast Erosion Blankets, LLC reserves the right to charge a handling fee on all Pre-Pay and Add shipments.

CHANGES AND CANCELLATION, REJECTION, CLAIMS

- A. Orders placed with East Coast Erosion Blankets, LLC are not subject to cancellation, change, or suspension of deliveries except with East Coast Erosion Blankets, LLC consent and upon acceptable terms. East Coast Erosion Blankets, LLC is indemnified for any loss resulting from rejection of requests for cancellation, change, or suspension. All change orders are void unless confirmed in writing.
- B. Samples given are a representation of the manufacturing process. They are intended to be a representation of the final product. There is a glue additive added to some samples to ease with packaging process, this additive is not in the final product.
- C. It is the Customer's sole responsibility to verify count and condition of all shipped items prior to signing for the receipt of shipment. Shortages and damages should be listed on the carrier's Bill of Lading at the time of delivery. Claims of shortages or rejections for defects pursuant to the limited warranty must be made within ten (10) days of receipt of goods. East Coast Erosion Blankets, LLC reserves the right to inspect or otherwise request evidence of defect. Credit will be rendered on such defective units after satisfactory, at East Coast Erosion Blankets, LLC's sole discretion, verification of shortage or defect claim. - return of goods pursuant with the claim. Returned goods must be returned to the designated East Coast Erosion Blankets, LLC facility, transportation charges prepaid, within thirty (30) days, and must remain unaltered, further damaged or defaced in any way.
- D. East Coast Erosion Blankets, LLC is not liable or responsible for damage or loss after having received "in good order" receipts from the transportation carrier. East Coast Erosion Blankets, LLC will provide reasonable assistance to the Customer for claims made to the carrier on a timely basis.
- E. Returned product is subject to a 10% restocking fee, except in the event of manufacturing defect inspected and accepted by East Coast Erosion Blankets, LLC. All returns must be approved by East Coast Erosion Blankets, LLC prior to shipping and receipt. All approved return shipments are subject to East Coast Erosion Blankets, LLC shipping and receiving instructions. - F. Customer acknowledges that East Coast Erosion Blankets, LLC is solely fulfilling Customer orders and has not completed any investigation of the Customer's intended use, or the fitness of said products in relation to the Customer's intended use. Customer is solely responsible for verifying that the products supplied meet the federal, state, and local codes and regulations and specifications applicable for the intended use and/or at the intended location. East Coast Erosion Blankets, LLC shall at its sole discretion approve or not approve the return of goods or product that are devoid of any effect, but have been deemed non-compliant for federal, state, and local codes and regulations in relation to intended use and intended location.

STORAGE AND DELIVERY ADJUSTMENT LIABILITIES

A. In the event that Customer requests a "hold" of shipment or shipments beyond scheduled date for convenience of the Customer, East Coast Erosion Blankets, LLC reserves the right to request payment for the cost of warehousing, and additional costs in shipping or other expenses. Customer responsibility for costs will begin (30) thirty days after the original date of shipment.

PAYMENT AND LIENS

- A. Unless otherwise stated on an invoice or long-term Customer agreement document, all invoices shall be payable within terms. No withholding of funds, offsets, back charges or credits against amounts otherwise due East Coast Erosion Blankets, LLC is permitted without prior approval in writing by East Coast Erosion Blankets, LLC.
- B. All invoices are payable upon receipt and are not subject to withholding of funds as Customer issues claim of manufactured defect or damage. East Coast Erosion Blankets, LLC will make every effort to inspect, review and resolve said claims as timely as possible. However, until inspected, reviewed and resolved under subject of revised terms, the terms originally agreed to by both parties remain and funds payable.
- C. Any unpaid account shall entitle East Coast Erosion Blankets, LLC to exercise all available remedies and authority under the law, including but not limited to additional fees, liens and applicable litigation.
- D. East Coast Erosion Blankets, LLC reserves the right, at its sole discretion, to cancel discounts on any invoice not paid within the terms of payment. Customer is liable for value of any discounts cancelled due to lack of payment.
- E. In the event any balance remains unpaid past approved terms, East Coast Erosion Blankets, LLC can impose a service fee equal to 2% on the unpaid balance per month, or the maximum allowed by law, whichever is less) on all unpaid accounts.
